NOTIFICATION

(1) In exercise of powers conferred by sub-section (1) of section 3 of the West Bengal Agricultural Produce Marketing (Regulation) Act, 1972 (West Bengal Act XXXV of 1972 and hereinafter referred to as the 'said Act'), the Governor is pleased to declare the entire area of the District of Coochbehar as a market area within which the purchase and sale of agricultural produce/produces as specified in the West Bengal Agricultural Produce Marketing (Regulation) Rules, 1982 shall be regulated.

(2) In exercise of powers conferred by sub-section (2) of section 5 read with sub-section (1) of the said section of the said Act, the Governor is pleased to specify the name of the Market Committee as **Coochbehar Zilla Regulated Market Committee.**

(3) In exercise of powers conferred by sub-section (3) of section 1 of the said Act, the Governor is pleased to appoint the 17th day of October, 2014 as the date on which the said Act shall come into force in the market area mentioned hereinabove.

NOTIFICATION

- (1) In exercise of powers conferred by sub-section (4) of section 3 of the West Bengal Agricultural Produce Marketing (Regulation) Act, 1972 (the West Bengal Act XXXV of 1972 and hereinafter referred to as the 'said Act'), the Governor is pleased to declare that the entire market area for which Coochbehar Sadar Regulated Market Committee, Tufanganj Regulated Market Committee, Mathabhanga Regulated Market Committee, Mekhliganj Regulated Market Committee, Dinhatā Regulated Market Committee and Haldibari Regulated Market Committee were constituted under sub-section (3) of section 5 read with sub-section (1) of that section of the said Act shall cease to be a market area with immediate effect and the said Market Committees in respect of the said market areas shall stand dissolved.
- (2) The unexpended balance of the Market Committee Fund and other properties and liabilities of the Market Committees referred to hereinabove shall vest in the State Government free from all encumbrances.
- (3) The Director of Marketing and Ex-officio Additional Director of Agriculture (Marketing), West Bengal shall depute officers not below the rank of Agricultural Marketing Officer to make inventory and take over charge of the unexpended balance of the Market Committee Fund and other properties and liabilities of the aforementioned dissolved Regulated Market Committees and their all bank accounts, securities, advances, properties and interests stand in their respective names shall thereupon be controlled by such officers according to the instruction issued by the Director of Marketing and Ex-officio Additional Director of Agricultural Marketing, West Bengal.
- (4) The value of property of the dissolved Market Committees vested in the State Government under clause (b) of sub-section (4) of section 3 of the said Act shall be the book value of the property according to the last updated balance sheet of the aforesaid six dissolved Regulated Market Committees subject to update provision or depreciation at rate recognised under the Income Tax Laws, but if no such balance sheet is available, the value determined by the State Government shall be final.
