Sir,

The government has decided that there should be one Zilla Regulated Market Committee in each district under the West Bengal Agricultural Produce Marketing (Regulation) Act, 1972. In pursuance of the decision, the existing Regulated Market Committees have been dissolved for 11 (eleven) districts and necessary Notifications have already been issued in this regard. The composition of the Zilla Regulated Market Committee is given below :-

Similar Notification for remaining seven districts is being issued. Henceforth, the duties and powers of the Zilla Regulated Market Committees shall be in accordance to the West Bengal Agricultural Produce Marketing (Regulation) Rules, 1982.

Taking over of all Assets, Liabilities, Bank Accounts etc. is being entrusted with the Deputy Directors of Agricultural Marketing (Administrative) under the Agricultural Marketing Directorate. A general Notification is being issued in this regard.

Subsequently, once the assets and the accounts are frozen, they shall be transferred to the newly created Zilla Regulated Market Committee by Specific Orders from time to time.

A general Notification is being issued for validation of agreements made the dissolved RMCs, continuance of legal proceedings by or against the dissolved RMCs, validation of licence issued by the dissolved RMCs to the respective Zilla Regulated Market Committee.

A general Notification for redeployment of staff of dissolved RMCs to the newly created Zilla Regulated Market Committees is being issued.

You are requested to kindly convene the Zilla Regulated Market Committee Meeting at the earliest to discuss the following -

- a) Taking stock of ongoing developmental works.
- b) Licensing and revenue collection
- c) Opening of new Bank Account.

Over and above, the Government has permitted engaging 06 (six) nos. of Civic Volunteers for security and protection of newly set up Krishak Bazars.

It has further been decided that the newly constructed Krishak Bazaars in the Districts will come under the administration of Zilla Regulated Market Committee. To achieve this effect, the Krishak Bazars will be notified as Sub-Market Yards under the control of respective Zilla Regulated Market Committee.


