- G) The Space will be given only on lease rent basis per sft per month and a lease agreement deed will be executed with the Lessee (Successful applicant) and the Lessor as per Govt. norms and Law.
- H) Electric Power connection from WBSEDC Ltd, electric bill and other incidental charges, i.e Fire disfigures, Insurance, security etc will be borne by the lessee from his/her own cost. Only street light will be maintained by the RMC authority. No any claim will be entertained in respect of storage goods of space/stall against any type of damage by any natural calamity, stolen or other incident.
- I) Total non-refundable premium amount will be deposited at a time within one month after receiving of formal approval letter. Failing which formal approval letter is liable to be cancelled. After full payment of non-refundable premium the lessee may take possession of the space/stall, in that case lease agreement deed will be executed from the date of taken over of possession of space / stall. No part payment will be entertained.
- J) The lessee (Successful applicant) should not make any alternation, or any addition or any type of extension of the demised premises or any structure or erection thereon without the written permission of the lesser.

- L) No Application Form will be issued or received at this office after stipulated date and time.

- N) Lease Period of space is 31 Years from the date of execution of lease deed and after that it may be renewed for 31 years to pay a mutation fee as desired by the District Committee, Malda Zilla RMC. The monthly rent will be increased as per Govt Norms after lapse of every succeeding (5) five years consecutively.
- 0) The space/stall will not be used for stock Cement, Rod, inflammable product, any intoxicating drug, marble etc. The space /stall will be use for Agril Commodities or its product or it's by product. The space will not use for retail sale of vegetables or fruits.
