

## Notice Inviting Tender

Sealed tender in prescribed format is invited under two Bid system i.e. 'Technical Bid' and 'Financial Bid', by the Director, Netaji Subhas Training Institute of Agricultural Marketing (NSTIAM), Baidyabati, the training institute of West Bengal State Agricultural Marketing Board, Government of West Bengal, from bonafide, reliable, experienced (at least three years of similar job) and resourceful agencies for **Food Service Management at the Canteen in the Hostel building of NSTIAM** for a period of 01 (one) year from the date of engagement, extendable for a further period of 01 year or until engagement of new agency, whichever is earlier.

Blank Tender Form will be available from the Accounts' Section of the aforesaid office situated at Sasmal Para, Baidyabati, Hooghly 712222, **from 15-02-2021 to 28-02-2021 between 11:00 AM to 3:30 PM** on all working days by submitting Rs 1000/- (One thousand only) as the non-refundable tender processing fees only by Cash/Bank DD (drawn in favour of "WBSMB-NSTIAM", payable at Baidyabati).

Sealed Tender is to be dropped in the locked 'Tender Box' kept in the said office address **upto 05:00 P.M. on all working days from 16-02-2021 to 01-03-2021.**

An Earnest Money Deposit (EMD) of Rs. 10000.00 (Rupees ten thousand) only by Bank DD drawn in favour of "WBSMB-NSTIAM", payable at Baidyabati, is to be deposited along with the tender documents in the 'Technical Bid' envelope. Late submission will not be considered. EMD exemption is allowed for those having Small Scale Industry (MSME) Part II or National Small Industries Corporation (NSIC) certificate.

Opening of Tender for **Technical Evaluation is scheduled on 01-03-2021 at 12.30 P.M** in the office of the Director, NSTIAM (aforesaid office address). Bidders, who will be qualified in Technical Evaluation, shall appear in the **Financial Evaluation process on 04-03-2021 at 12:30 P.M.** The bid will remain valid for 180 days from the last date of submission of tender.

The Agency who have already applied in the NIT vide no: 002/2020-21/ NSTIAM Dated: 07/01/2021 & willing to apply for R1, need not to deposit the NIT fees. However, they have to submit their NIT document freshly with EMD.

The Director, NSTIAM reserves the right to amend / withdraw any of the terms and conditions of the Tender or to reject any or all tenders without giving any notice or assigning any reason. The decision of the Director, NSTIAM in this regard shall be final and binding on all.
