2. The Rate to be quoted inclusive of all taxes and charges.
3. Tender Paper will be available in this office to the eligible bidder by depositing Tender Fees Rs.750/-.
4. The bidder should quote their rates both in figure and words.
5. The successful tenderer will have to execute an agreement after depositing earnest money @ 2% (Two Percent) of the quoted amount in the shape of Bank draft in favour of **West Bengal State Marketing Board Fund/Cash**.
6. The successful tenderer will have to execute an agreement (with 2 sets of non-judicial stamp paper of Rs.100/-) after depositing agreement fees of Rs.1000/- in the shape of Bank draft in favour of **West Bengal State Marketing Board Fund/Cash**.
7. In case of failure of compliance of the terms and conditions LOA/Work Order, the contract will be terminated along with forfeiture of earnest money.
8. Time of completion of work is 60 (Sixty) days from the date of work order.
