- 1.1 West Bengal State Agricultural Marketing Board invites EOI in 2(Two) sealed envelopes comprising the Technical Experience details and the Financial Offer from bidder for DISTRIBUTION OF 16 (Sixteen) STALLS ON RENT TOWARDS SALE OF ORGANIC PRODUCE / PRODUCT.
- 1.2 The bidder should have experience on marketing of Agricultural Produce / product having India Organic Logo which includes whole range of Agricultural, Horticultural, Animal Husbandry, Fisheries, Textiles product.
- 1.3 Period for allotment of stall is 5 (Five) years with a provision for extension of next 5 (Five) years subject to satisfactory performance.
- 1.4 The intending Individual / FPO / FPC / FIG / SHG / Company must have FSSAI license, Trade License, PAN Card, P.Tax Certificate, Current Professional Tax Challan Acknowledgement Receipt or current Professional Tax payment Certificate (PTPC), GST Registration Certificate (if required) during submission of bid.
- 1.5 In case the intending bidder did not obtain FSSAI license during submission of bid, should submit declaration on non-judicial stamp paper of Rs. 100/- that individual/organisation should obtain FSSAI license before commencement of business at allotted space.
- 1.6 The candidature of the bidder will be treated as cancelled, if he fails to obtain licence of FSSAI within 03 (Three) months from the date of allotment.
- 1.7 Under any circumstances the allottee could not commence his business at the allotment space without having FSSAI licence.
- 1.8 Award of the bid is at the sole discretion of West Bengal State Agricultural Marketing Board.
- 1.9 A pre-bid meeting will be held in the office of West Bengal State Agricultural Marketing Board, at the address given above on 22/10/2024 at 02.00 pm.
- 1.10 Date of submission Technical & Financial Bids for the EOI to be submitted in separate envelopes from 23/10/2024 to 30/10/2024 on any working day from 11.00 am to 04.00 pm in the office of the West Bengal State Agricultural Marketing Board.

Terms of Reference for ' DISTRIBUTION OF STALLS ON RENT TOWARDS SALE OF ORGANIC PRODUCE / PRODUCT AT Organic Haat, Rajarhat, New Town'.

Introduction

West Bengal State Agricultural Marketing Board has constructed a G+5 storied state of art building (Organic Haat) at Plot No.IIE-67/2,Rajarhat, New Town for providing support to the stakeholders producing and / or selling organic produce / product. The building is situated just on the left side of the Biswabangla Sarani, 300 Mtr. from the Biswasbangla Gate towards Netaji Subhas Chandra Bose International Airport.

Facilities

There are 3604 Sqft. (approx.) covered space in each floor with facilities of –

- Modern toilet facilities for both Gents & Ladies.
- First floor and Second floor of the building containing 16 (Sixteen) Stalls (Area of stalls mentioned in Annexure-4).
- Proper electricity arrangement.
- Water arrangements.
- Air-conditioning system having glass door and rolling shutter.
- This building is equipped with escalator up to the 3rd floor.
- There are 2 (two) lifts and 2 (two) stair cases for facilitating the mobility of common people.
- There is common facility of a Food Court at 3rd floor in the said building to provide delicious organic food to common people.
- Each and every stall has separate entrance.
- The entire building is equipped with closed circuit camera and firefighting arrangements duly approved by the Competent Authority.
- The Authority will provide Security Personnel for the entrance of the building.

SECTION 3

GENERAL TERMS AND CONDITIONS

- 3.1 The intending bidders must have FSSAI license, Trade License, PAN Card, P.Tax Certificate, GST Registration Certificate (if required). In case the intending bidder did not obtain FSSAI license during submission of bid, should submit declaration on non-judicial stamp paper of Rs. 100/- that individual/organisation should obtain FSSAI license before commencement of business if considered for allotment of a stall.
- 3.2 The bidder must commence his business within 30 (thirty) days from the date of allotment of space, failing which, his allotment will be treated as cancelled. The Earnest Money deposited by the bidder will be forfeited by the authority.
- 3.3 The bidder who submitted declaration about non availability of FSSAI licence during submission of tender will be allowed for a period of maximum 03 (three) months from the date of allotment to start his business, failing which his allotment will be cancelled followed by forfeiture of earnest money.
- 3.4 Under any circumstances the allotted stall should not be remain unutilized for a period of 15 (fifteen) days at a stretch. In that case Earnest Money will be forfeited and allotment will be revoked.
- 3.5 Every items which are to be sold must have **India Organic Logo** issued by the Competent Authority of the Government of India or **PGS Green** or **Organic Certificate** under Paramparagata Krishi Vikash Yojana.
- 3.6 Period for allotment to the successful bidder will be initially for 5 (Five) years, with a provision for extension of next 5 (Five) years subject to satisfactory performance.
- 3.7 Relaxation on rent will be allowed @ 50% for first 6 (Six) months and @ 25% for next 6 (Six) months.
- 3.8 Assessment of rent for the period after completion of first 5 (Five) years will be finalized with mutual agreement.
- 3.9 Enhancement of rent will be 10% after completion of 2.5 consecutive years.
- 3.10 The selected individual / agency will have to pay electricity charges for consumption as per respective own meter, for which application to the concerned authority to be made.
- 3.11 The selected individual / agency will maintain cleanliness of the space allotted in favour of him out of his own resources and maintain harmony with the neighbours mutually.
- 3.12 No permanent car parking within the building complex will be allowed for the selected agency.
- 3.13 This Department will not be responsible for any damage in their own space except supply of water. Bidder will also be responsible to maintain glass door and rolling shutter for their own shop.
- 3.14 Individual shop should be well decorated and furnished attracting public, as far as possible.
- 3.15 Intending bidder may apply for maximum 02 (two) nos. of stalls irrespective of category and floor. In that case the bidder has to submit separate EOI for each stall.
- 3.16 The allottee will abide by law of land.
- 3.17 In case if the allottee wants to quit from the agreement he has to intimate to the authority at least 03 (Three) months before to exit. In that case his earnest money will be refunded without any interest. The condition of the allotted space must be as it was handed over to him at the time of exit of the allottee within the period of contract security money will be forfeited.
- 3.18 West Bengal State Agricultural Marketing Board reserves the right to mitigate dispute, if arises, with any of allottee during the contract period.

SECTION 4 INSTRUCTION TO BIDDERS

4.1 Site Visit

A bidder shall be deemed to have full knowledge of the facilities and infrastructure in the building/ surroundings that the successful bidder is required to operate from.

The bidder may undertake site visit with prior intimation to the West Bengal State Agricultural Marketing Board on working day.

4.2 Pre-bid Conference

Interested bidders can attend a pre-bid conference at 02.00 pm on 22/10/2024 at the office of West Bengal State Agricultural Marketing Board. The purpose of the conference will be to clarify issues and to answer questions on any matter relating to this document that may be raised at that stage. Any amendment of the bid document that may become necessary as a result of the pre-bid conference shall be made by West Bengal State Agricultural Marketing Board and distributed to all bidders.

4.3 Time of Submission

The indicative time schedule of the submission process, described in different parts of the document, is provided in the Annexure-3.

Sealed bids have to be submitted (both Technical & Financial Bid) in separate envelope from 23/10/2024 to 30/10/2024 to the office of West Bengal State Agricultural Marketing Board from 11:00 am to 04:00 p.m. West Bengal State Agricultural Marketing Board may, at its own, sole discretion, extend the last date for submission of bids by issuing an amendment and the bidders shall be up to the modified date as extended. Financial Bid will only be opened for the bidder who is technically eligible as per criteria laid down in EOI.

4.4 Late Bids

Any bid received by West Bengal State Agricultural Marketing Board after the deadline for submission of bids will be out rightly rejected.

4.5 Fees Payable

The following fees are payable at various stages of the bidding process:

1. A) Earnest Money for an amount of Rs. 20,000/- to be paid by the intending bidders during submission of bid in the form of Demand Draft (Payable at Kolkata) or Online Transfer in favour of West Bengal State Marketing Board Fund.

B) Earnest Money of the unsuccessful bidder will be refunded on submission of application after completion of bidding process.

C) Earnest Money of the successful bidder will be converted as Security Deposit and that will be refunded (without interest) after successful completion of the contract period.

2. The preferred agency will have to deposit security money for an amount of Rs. 50,000/- (adjusting the Earnest Money) before execution of agreement with the authority.

4.6 Amendment of Bid Document

At any time prior to 03 (three) days from the last date for submission of the bid, West Bengal State Agricultural Marketing Board reserves the right to add/ modify/ delete any portion of the bid document by the issue of an addendum, which will be sent to all bidders. In case of amendment of bid document, West Bengal State Agricultural Marketing Board may, at their own discretion, extend the bidding period only under exceptional circumstances. West Bengal State Agricultural Marketing Board will not entertain any request from any bidder to extend the bidding period.

4.7 Settlement of disputes

For any dispute arising during the bidding process, the decision of West Bengal State Agricultural Marketing Board shall be final and binding on all parties.

4.8 Clarifications

West Bengal State Agricultural Marketing Board may call for clarifications regarding certain aspects of the bids received. Such clarifications are required to be provided in writing within the specified time frame and would be considered as part of the bid. However, bidding will not be permitted to change any aspect of their financial bid or any term that might materially affect the financial bid after the last date for submission of bids.

4.9 Law applicable

Indian Laws shall be applicable for the process. No cases shall be entertained beyond the jurisdiction of Kolkata.

4.10 Right to accept/ reject

West Bengal State Agricultural Marketing Board reserves the right to accept or reject any bid without assigning any reason thereof, and without thereby incurring any liability to the affected bidders.

4.11 Indemnification

The bidder will be required to indemnify West Bengal State Agricultural Marketing Board against all liabilities, direct or indirect arising out of the bidding process.

4.12 Period of Contract

Period for allotment of stall is initially for 5 (five) years with a provision for extension of next 5 (five) years subject to satisfactory performance.

4.13 Payments

Selected agency shall pay to the West Bengal State Agricultural Marketing Board the monthly rental for the allotted space within 10th of the every month. Failure for payment of rent during 3 (Three) consecutive month, allotment of stall will be cancelled along with forfeiture of Security Money deposited by the agency.

4.14 Technical Bid

The technical bid will consist of FSSAI license, Trade License, PAN Card, P.Tax Certificate, Current Professional Tax Challan Acknowledgement Receipt or current Professional Tax payment Certificate (PTPC), GST Registration Certificate (if required).

4.15 Financial Bid

- ❖ The Price quoted shall be at the rate of per square feet for monthly rental basis for the allotted space.
- ❖ The price quoted by the intending bidder shall excluding GST as applicable.
- ❖ Assessment of rent for the period after completion of first 5 (Five) years will be finalized with mutual agreement.
- ❖ Taxes, if any, that may be payable for running the stall to the Government of India / State Government shall be borne by allottee of the stall.

4.16 Selection of Stall Holder

Both technical and financial offer shall be considered for evaluation the bid. West Bengal State Agricultural Marketing Board will first assess the technical eligibility of the intending bidder. Financial bid of the technically qualified bidders will be opened in presence of the technically qualified bidders or his authorized representatives.

The quoted rate of the highest bidder will be finalized as rate of rent for each stall. Stall will be allotted following the open lottery in presence of every interested qualifying bidders based on the rate accepted by interested technically qualified bidders i.e. as rate of rent of highest bidder giving their acceptance in writing. (Layout of the stalls are enclosed Annexure-4).

4.17 Bid Security:

After receiving the Letter of Acceptance and before entering into the Contract Agreement, the successful bidder shall have to furnish an amount of Rs. 50,000/- (Rupees Fifty Thousand) only as interest free refundable Security Deposit to the West Bengal State Agricultural Marketing Board which will be refunded on expiry of the contract agreement and fulfillment of terms and conditions of the agreement.

SECTION 5

BID FORMAT & CONTENTS

5.1 Sealing, Marking and Submission of Bids

Each bid shall contain the bid security, technical proposal and the financial proposal. The original bid shall be enclosed in three separate sealed covers. Each sealed cover shall be marked Strictly "Confidential-Bid for Distribution of Sall at Organic Haat, Rajarhat, New Town" and should be addressed to the:

Separate envelopes to be marked envelope (i) Earnest Money; (ii) Technical Bid (iii) Financial Bid depending on the contents. If the envelopes are not sealed and marked, West Bengal State Agricultural Marketing Board will assume no responsibility for the misplacement or premature opening of the bid. A bid opened prematurely due to this reason may be rejected by West Bengal State Agricultural Marketing Board within the stipulated date.

5.2 Modification of Bids

If the bid is submitted prior to the last date of submission, the bidder can modify or make corrections to it upto the last date and time of submission. Such modification/ correction, if any, has to be submitted in sealed envelopes to the Chief Executive Officer, West Bengal State Agricultural Marketing Board, Kamal Guha Krishi Bipanan Bhawan, 729, Anandapur, Kolkata 700 107.

5.3 Initialing of Bids

The bid shall be typed and each page shall be duly signed by the bidder/ Authorised Signatory.

5.4 Bid opening Procedure

Envelope (i) Earnest Money of the bid, with requisite documents shall be opened first, if found condition of the bid satisfied envelope (ii) i.e. Technical Bid, with requisite documents shall be opened and if found eligible envelope (iii) i.e. Financial Bid shall be opened.

5.5 Bidder's Declaration

All bidders have to provide an Affidavit in accordance to the format given in Annexure 2. If, at any stage, the information given in Annexure-2 is found to be materially incomplete or incorrect or false (in the assessment of West Bengal State Agricultural Marketing Board), West Bengal State Agricultural Marketing Board reserves the right to reject the bid and allotment and also legal action may be taken against the bidder.

5.6 Time Schedule

The indicative time schedule of the submission process, described in different parts or the document, is provided in the Annexure-3.

5.7 Language of the Bid

All correspondence and contracts shall be in English

5.8 Currency of Bid

All amounts in the bid shall be expressed in Indian Rupees and if there be any difference between words and figures, the bid shall stand cancelled.

5.9 Bid Contents

The submissions shall be made in 03(three) Envelopes, namely, Envelope (i); Envelope (ii) and Envelope (iii). The desired content(s) of such envelope is described below.

5.9.1 Envelope (i) (Earnest Money)

Demand Draft in favour of West Bengal State Marketing Board Fund / Self authenticated document of NEFT or Net Banking.

5.9.2 Envelope (ii) (Technical Bid)

It should contain:

- I. Authorisation by way of Power of Attorney of the person signing the Bid.
- II. Technical Proposal.

The submissions should be done in the sequence as shown below.

- I. Information about the Organisation:
 - i. Name of the bidder
 - ii. Contact address and name of person duly authorized to clarify, negotiate and finalise the bid (with contact number and e-mail)
- II. Technical Experience & Qualifying Criteria Documentation:
 - i. Experience in managing Sale Counter of Organic Product.
 - ii. Average turnover of the bidder for last three Financial Years.
 - iii. Authenticate document for FPO / FPC / FIG / SHG / Company.
 - iv. Certificate of the India Organic Logo issued by the Competent Authority of the Government of India or PGS Green or Organic Certificate under Paramparagata Krishi Vikash Yojana for the product to be sold in the counter with FSSAI license, Trade License, PAN Card, P.Tax Certificate, GST Registration Certificate (if required). In case the intending bidder did not obtain FSSAI license during submission of bid, should submit declaration on non-judicial stamp paper of Rs. 100/- that individual / organisation should obtain FSSAI license before commencement of business at allotted space.
- III. Bidder's request for amendment to bid document:

If desired the bidder may indicate the amendment(s) in the bid document.
- IV. Annual reports and audited balance sheet duly signed by the bidder for last three years.
- V. Return of Bid Document (in case of cancellation of EOI):

The Original Bid document will be returned in sealed condition along with Earnest Money.

- VI. Additional Information:

The bidder may add any further information which may be considered relevant for the evaluation of the bid. The bidder may attach other documents giving a legible list. No documents will not be accepted after opening of bid.

5.9.3 Envelope (iii) : (Financial Bid)

It should contain:

- I. **MONTHLY RENT:** The monthly rent at the rate of per Sqft. for each Stall of Organic Haat, Rajarhat, New Town in the format given below. A copy of this format is to be used for Envelope (iii) (Financial Bid).

- N.B.:** 1) However, the price should not be quoted in Envelope (ii) (Technical Bid).
2) In case of single floor it is not required for quoting other floor.

SECTION 6 BID EVALUATION

6.1 Uncovering Procedure:

First of all Envelope No. (i) Earnest Money, of the bid will be opened in the presence of the representatives of the bidders. If the document of Earnest Money does not satisfy as per provision of the Bid, then rest envelopes will not be opened. Envelope No. (ii) of the bid will be opened subsequently. If relevant documents do not meet the requirements as per clause 5.9.2 (Envelope No. ii), Envelope (iii) will not be considered for further action.

If documents are considered to be acceptable by the Tender Committee of the West Bengal State Agricultural Marketing Board only then Envelope (iii) will be opened on scheduled date. Information regarding the examination, clarification, evaluation and comparison of bids, and recommendations for the award of a contract shall not be disclosed to the bidders or any other personnel officially concerned with such process until the award to the successful bidder has been announced.

6.2 Validity of Bids:

The bid shall remain valid and open for acceptance for a period of 180 (one hundred eighty) days after the due date of submission of bid.

In exceptional circumstances, prior to the expiry of the original bid validity period, Chief Executive Officer, West Bengal State Agricultural Marketing Board may intimate the bidder(s) for specified extension in the period of validity and the responses thereto shall be made in writing or by e-mail, followed by written confirmation.

A bidder, if agreed, will neither be required nor permitted to modify their bid, but will be required to extend validity of their bid and bid security correspondingly.

No bidder shall be allowed to withdraw the bid during the interval between the last date for submission of bid and the expiry of the period of validity of bids specified in bid documents or as extended by the bidder.

6.3 Evaluation:

- 1) On the basis of requisite documents bidder will be declared as a technically qualified.
- 2) Financial Bid of the technically qualified bidder will be opened on scheduled date and time which will be declared during declaration of technically qualified bidder.

6.4 Final Selection:

Selection will be made on the basis of the highest quoted value received from the technically qualified bidder.

SECTION 7
STEPS TO BE FOLLOWED AFTER SELECTION

7.1 Notification of Award:

Prior to the expiry of the period of bid validity or subsequent extension West Bengal State Agricultural Marketing Board will issue a Letter of Acceptance (LOA) to the successful bidder in writing.

7.2 Contract Agreement:

Within 07 (seven) days of the receipt of LOA, the selected bidder(s) shall enter into a Contract Agreement with West Bengal State Agricultural Marketing Board duly signed and executed on Stamp paper of appropriate value adjudicated by relevant competent authority. At the time of the execution of the Agreement, the successful bidder(s) need to submit a refundable Security Deposit as stipulated in this document along with requisite certificate as per provision of the EOI document from the appropriate Authority for running the allotted stall.

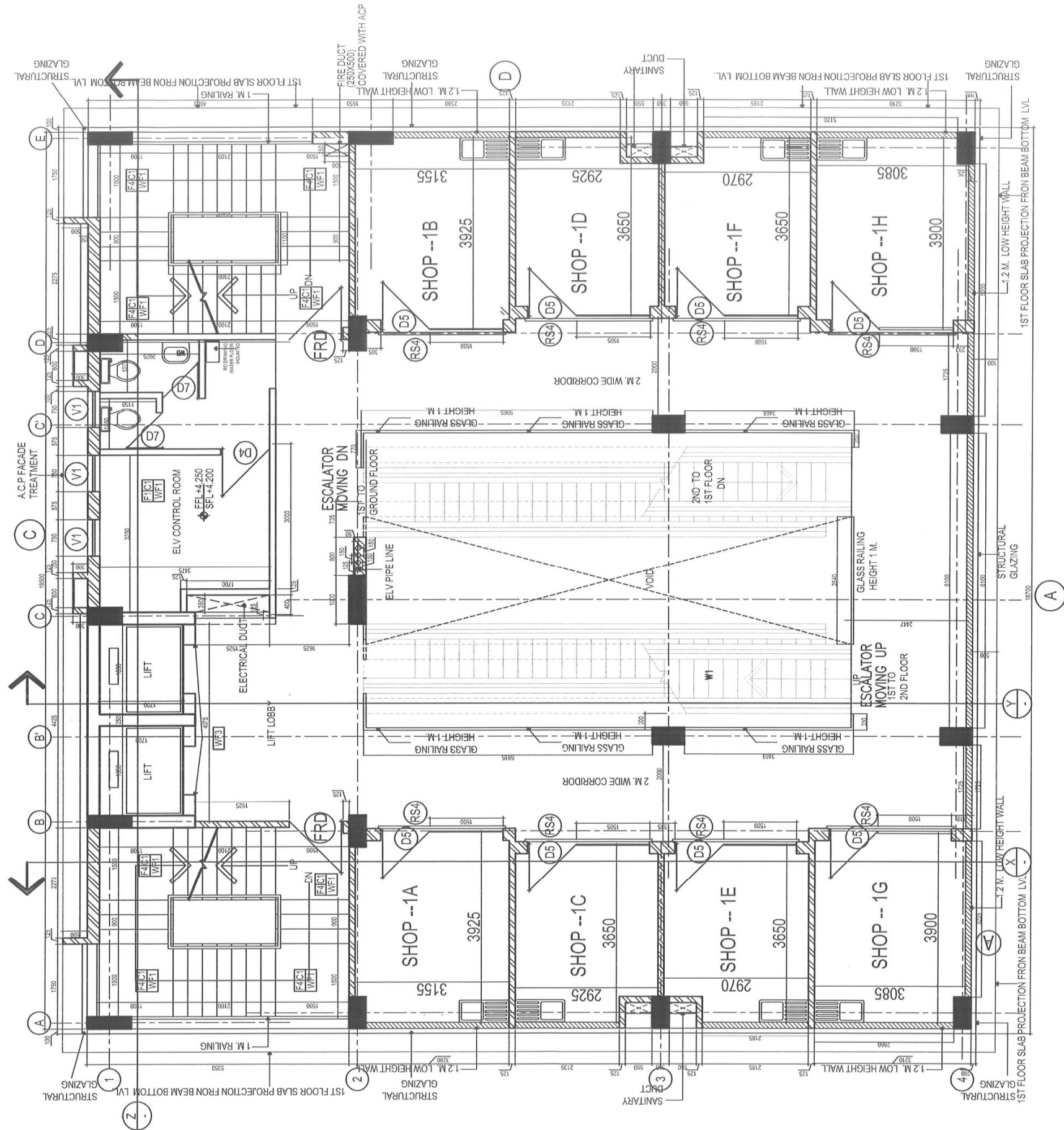

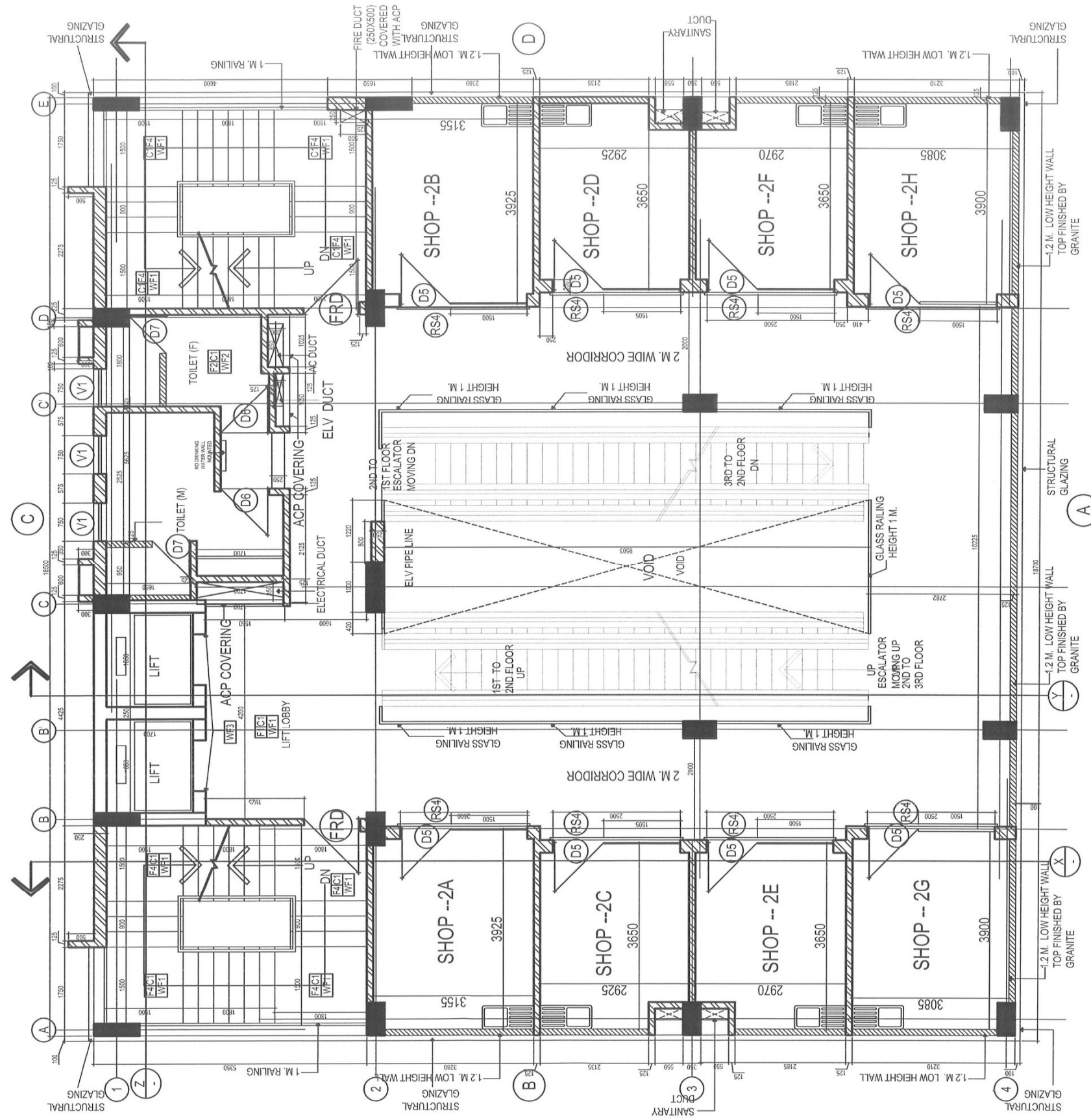
