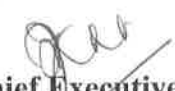

Terms and Conditions

1. The Chief Executive Officer, West Bengal State Agricultural Marketing Board reserves the right to accept or reject any bid without assigning any reason thereof and to cancel the tender at any stage.
2. The successful tenderer will have to execute an agreement (with 2 sets of non-judicial stamp paper of Rs.10/-) after depositing agreement fees of Rs.500/- in the shape of Bank draft in favour of **West Bengal State Marketing Board Fund/Cash**.
3. In case of failure of compliance of the terms and conditions laid down in LOA/Work Order, the contract will be terminated along with forfeiture of earnest money.
4. Time of completion of work is 15 (Fifteen) days from the date of work order.
5. Statutory deduction will be made from each bill as per norms.
6. Earnest Money will be converted as Security Deposit and Balance Security Deposit (3% in total) will be deducted from every bill.
7. Security Deposit will be released after expiry of 30 days after completion of defect liability period.
