2. Tender Paper will be available in this office to the eligible bidder by depositing Tender Fees Rs.500/-.
3. The successful tenderer will have to execute an agreement after depositing earnest money @ 2% (Two Percent) of the tendered amount by Cash or Bank draft in favour of **West Bengal State Marketing Board Fund/Cash**
4. The successful tenderer will have to execute an agreement (with 2 sets of non-judicial stamp paper of Rs.10/- after depositing agreement fees of Rs.500/- by Bank draft in favour of **West Bengal State Marketing Board Fund/Cash**.
5. In case of failure of compliance of the terms and conditions LOA/Work Order, the contract will be terminated along with forfeiture of earnest money.
6. Time of completion of work is 15 (Fifteen) days from the date of work order.
7. Statutory deduction will be made from each bill as per norms.
